

PROPOSAL

(Subject: Approval of changes and additions to the Company's business lines)

To: The General Meeting of Shareholders of Tan Phu Vietnam Joint Stock Company

- *Based on the 2020 Enterprise Law, the 2025 amended Enterprise Law, and the implementing guidelines;*
- *Based on the Securities Law of 2019, the amended Securities Law of 2024, and the guiding documents for their implementation;*
- *Based on Decision 36/2025/QĐ-TTg dated September 29, 2025 of the Prime Minister;*
- *Based on the Charter of Organization and Operation of Tan Phu Vietnam Joint Stock Company (“the Company”);*
- *Based on the company's situation and operational requirements ,*

On September 29, 2025, the Prime Minister of the Socialist Republic of Vietnam signed Decision No. 36/2025/QĐ-TTg on the promulgation of the Vietnamese economic sector classification system (“Decision 36”) to replace Decision No. 27/2018/QĐ-TTg. Decision 36 updated, adjusted, and supplemented the sector codes and changed the detailed descriptions of some business sectors to suit the socio-economic development situation.

Based on this, the Company needs to review its entire registered business activities, compare them with the regulations in Decision 36, and update the changes to the business activities at the Business Registration Authority. Therefore, the Company's Board of Directors respectfully submits to the General Meeting of Shareholders for consideration the following changes and additions to the Company's business activities:
